

Terms and Conditions for Affiliate Program - AFFILIMOON

Please read the following Terms and Conditions carefully before joining our affiliate program. By participating in the program, you agree to comply with these terms:

1. **Eligibility:** a. You must be at least 18 years old or of legal age in your jurisdiction to participate. b. Individuals or entities involved in illegal gambling activities are not eligible to become affiliates.
2. **Application Process:** a. To apply for the affiliate program, you must complete our online application accurately and provide all requested information. b. We reserve the right to accept or reject applications at our discretion. c. You will be notified of your application status via email.
3. **Affiliate Responsibilities:** a. As an affiliate, you agree to actively promote our online casino through legitimate marketing channels and methods. b. 6. **Intellectual Property:** a. You are granted a limited, non-exclusive, non-transferable license to use our trademarks and promotional materials solely for the purpose of promoting our online casino. b. You shall not modify, alter, or use our intellectual property in any manner that may harm our brand reputation or violate any intellectual property rights.
7. **Termination:** a. We reserve the right to terminate the affiliate agreement at any time, without prior notice, if you violate these Terms and Conditions. b. Termination may result in the forfeiture of all outstanding commissions. c. Either party may terminate the agreement by providing written notice with a reasonable lead time.
8. **Limitation of Liability:** a. We shall not be liable for any indirect, incidental, consequential, or punitive damages arising from your participation in the affiliate program. b. You agree to indemnify and hold us harmless against any claims, costs, damages, or liabilities arising out of your actions as an affiliate.
9. **Modifications:** a. We reserve the right to modify or amend these Terms and Conditions at any time. b. Any changes will be communicated to you via email or through our affiliate portal. c. Your continued participation in the program after such modifications will constitute your acceptance of the revised Terms and Conditions.
